

NOTICE OF SUBSTITUTE TRUSTEE'S SALE

WHEREAS, on August 27, 2013, **Renea Chappell and Jackey Lee Chappell** executed a Deed of Trust (the "Deed of Trust") conveying to Kirk L. Lee, Trustee, certain real property more particularly described in Exhibit A, which is attached hereto and incorporated herein by reference, together with all improvements, fixtures and personal property located thereon or used in connection therewith and certain other personal property as more fully described in the Deed of Trust (all of the real and personal property covered by the Deed of Trust is hereinafter referred to collectively as the "Property"), said Deed of Trust being recorded in Document Number 109209-2013 of the Real Property Records of Lamar County, Texas; and



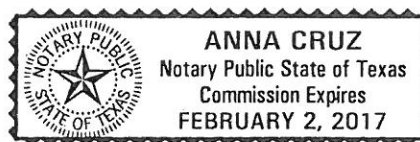


Exhibit A
