


AFFIDAVIT OF EXAMINATION OF TREASURER'S REPORT



Note: Due to existing and ongoing financial software inconsistencies a disclaimer is therefore issued by the County Treasurer to the accuracy of these monthly financial reports.






Commissioner Precinct One


